### **Rules Review Committee:**

1. The 12-14 year old division team shortage issue at each game. Dynamo will provide a list of the 11 year olds to play up if necessary to the coaches in the 12-14 year old age division.
2. The tournament issue when a team is not present for the game to start on time.
  - a. Dynamo will allow up to 10 minutes for the team to show up before awarding 1 point to the opponent.
  - b. Dynamo will consider a team to have forfeited if not present within 15 minutes of the start time for the game. The opponent will then have won the game with a score of 1-0.
3. Trounce issue. Referee should be contacted if there is too much discrepancy in the scoring such as one player on a team is scoring multiple goals and the coach is not making any changes to position or play to slow the scoring down.
